- 3. Download and fill out the application for office.
- 4. Write a letter of intent.
- 5. Send these two items (email is fine) along with a copy of your blue card to the following:
 - local B&B
 - local seneschal
 - local office in which you are applying
 - regional officer of position you are applying
 - kingdom officer of position you are applying
 - kingdom seneschal.
- 6. Remember:
 - For reeve, you must send a copy of driver's license
 - You must be a member of the SCA to hold office

From the BOD: Dated: September 25, 2021

The SCA Board of Directors aims to balance getting Society participants back to doing the things we love with measures that support Kingdoms in protecting all that people have worked so hard for. Our COVIDSafe Resolutions provide a flexible, risk-based framework that allows Kingdoms in the United States and Canada to put in place a core set of requirements that event organizers and attendees must adhere to, based on their current environment and public health directions and advice.

As more information becomes available, the Board reviews and updates its resolutions in line with its responsibility to act diligently, with due care, and in good faith. This is never more important than with issues related to the health and safety of our fellow participants. In line with this approach, based on changing circumstances and updated expert advice, on September 25, 2021, the Board has resolved the following:

Proof of Fully Vaccinated Status Or Negative COVID Test

In addition to the existing policy allowing Kingdoms to establish a mask policy, Kingdom Seneschals in consultation with the Crown shall have the discretion to implement the following policy requiring proof of COVID vaccination or a negative COVID test taken within 72 hours of an event start time from all event attendees:

- 1. Events are any activities defined in Corpora II.A, Society Events Defined.
- 2. Proof of being fully vaccinated must be in form of a government issued card (original or photograph) or an electronic record.
- 3. Proof of negative covid test must be issued from a licensed medical provider and presented in such paper form or electronic form that the event staff can verify its authenticity. Letterhead from a medical provider or an email address clearly identifying the medical provider as the sender of an electronic record shall constitute authentic proof.
- 4. All persons over the age of 18 must present government issued photo identification along with the proof of being fully vaccinated or a negative COVID test. Parents and guardians of minors must present their own identification along with proof of being fully vaccinated or a negative COVID test for all minors attending an event in their care.
- 5. Proof of vaccine or a negative test shall not be required for children under 12. Children that are aged 3 through 11 shall wear a mask.
- 6. In addition to the normal sanctions process, anyone challenging event staff regarding the enforcement of this COVID policy shall be denied entry to or be immediately removed from the event.
- 7. The Kingdom must have one person at a time checking the proof of being fully vaccinated or a negative COVID test at an event. The event organizer, or their designee, shall maintain a list of names and times of the person(s) conducting the check at the entrance. Once the entrance is closed at the event, said person(s) will sign a statement at the bottom of the list of names and times, which reads: "I have monitored the event entrance at the times noted above, and I have verified that each person entering the event during that time to have shown me proper identification, along with either proof of being fully vaccinated or a negative COVID test taken within 72 hours of the start of the event." The event organizer, or their designee, shall forward the signed statement to the Kingdom Seneschal, or their designee, who shall maintain such records in accordance with the standards for retention of waivers.
- 8. Kingdom Seneschals shall notify the Society Seneschal where local, state, provincial, or national law supersedes this policy.
- 9. This policy shall not apply to Lochac and Drachenwald.

Covid Response - updated 09/02/2021

General Rules

- Ansteorra does not permit indoor events at this time. Local activities may be held indoors if SCA participation is limited to 25 or fewer. Social distancing must be maintained at all times and properly work masks are required.
- All participants over the age of 2 must wear face coverings at all in-person SCA functions in accordance with CDC guidelines. This includes both indoors and outdoors. Face coverings must be worn over the nose and mouth except while briefly eating and drinking. Participants must remain stationary and socially distant while unmasked to eat or drink. Face coverings should be in accordance with CDC guidelines on masks. For more information, see: https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/about-face-coverings.html.
- The SCA is not checking vaccine status. If a venue/site owner requires vaccine checks, we will abide by site rules.
- The following signage must be displayed prominently and preferably in multiple places at all in-person SCA functions. https://www.sca.org/wp-content/uploads/2021/05/052021EventSign.pdf
- All in-person events require a sign-in. We are required to gather modern name and some form of contact (email, phone number, address). Included is a proposed form for gathering this information.
- Feasts may not be held at this time.
- No SCA branch may provide food in a buffet or family style. Individually wrapped food items may be provided.
- There are to be no shared drinking vessels. This would include a water cooler with a spigot where individuals put their mugs or reusable cups to the spigot. Water coolers with single use cups are acceptable.
- Individuals may share food, but this will NOT be SCA sponsored and that must be clearly stated.
- Youth activities are prohibited at this time.

Rules for Food and Beverage A&S Entries

 Food and beverage entries must pre-register with the coordinator of the A&S/brewing competition.

- The activity coordinator must pre-arrange volunteer judges. Judges must voluntarily consent to sample the items. If no judges are able or willing to judge the item, then it may not be entered into the competition.
- Only the judges may try food or drink during the competition. This may include local landed nobility or royalty if they are part of the judging process. However, food and beverage items are not permitted to be sampled by the populace at large, even for populace choice competitions.
- All food and beverage items must be served in/on single use containers. If a judge needs a second sample, they must use a new plate or cup.
- Only one person may serve food or beverages, limiting the contact of the serving items.
- Distancing should be maintained while unmasked.


